AMENDMENT TO DECLARATIONS OF CONDOMINIUM OF SOUTHPOINTE, UNITS I, II, III, IV, AND V

- 1. SECTION 14.2(B) of each of the aforementioned Declarations is hereby amended by adding the following to the end of that section:
 - (B) ... Notwithstanding any provision of this Section 14.2(B) to the contrary, the Board of Directors of the Association may approve alterations to enclose the limited common elements consisting of patios and balconies. Such enclosures will be made in the manner and fashion permitted by the Board.
